Treviglas Academy uses the Gatsby Benchmarks as a guide to plan our CEIAG programme.

As part of our commitment to informing our students of the full range of employment, learning and training pathways on offer to them - we are happy to consider requests from training, apprenticeship, and vocational education providers – particularly with a local focus. This policy statement sets out the Academy's arrangements for managing the access of providers to pupils at the Academy. This complies with the Academy's legal obligations under Section 42B of the Education Act 1997.

Student entitlement

- All students in years 7-13 are entitled to find out about apprenticeship, employment and alternative technical training opportunities as part of a careers programme which provides information on the full range of education and training options available at each transition point (end of Year 11 and end of Year 13).
- To hear from a range of local and national providers about the opportunities they offer, including technical education and apprenticeships – through options evenings, information evenings, local careers fayres, assemblies, group discussions, and taster events.
- To understand how to make applications for the full range of academic and technical courses
- To understand how to make applications for the full range of academic and technical courses
- To learn about local and national Labour Market Intelligence, which will inform their career choices
- To evaluate and reflect on their careers provision at each key stage

Provider Access Legislation

The Provider Access Legislation specifies schools must provide at least six encounters for all their students – two in Years 8 and 9, two in Years 10 and 11 (all pupils in these year groups will be expected to access these encounters) and two in Years 12 and 13 (encounters need to be made available to all students in these year groups)

Further detail of the legislation:

- The Skills Act specifies schools provide at least six encounters with providers of approved technical education qualifications or apprenticeships.
- Two in Y8/9, two in Y10/11 (which are mandatory for all registered learners to attend) two in Y12/13 (which it is mandatory the school offer but optional for learners to attend).
- Two encounters in the same phase cannot be with the exact same provider.
- Schools should ask providers to whom access is given to provide information that includes the following— (i) information about the provider and the approved technical education qualifications or apprenticeships that the provider offers, (ii) information about the careers to which those technical education qualifications or apprenticeships might lead, (iii) a description of what learning or training with the provider is like, and (iv) responses to questions from the pupils about the provider or approved technical education qualifications and apprenticeships.
- Mandated for each registered pupil not just select groups.

Treviglas runs two careers fayres a year to facilitate this need where all students attend (apart from year 11s w.r.t. the summer careers fayre). Each Fayre is divided into a variety of sectors which reflect the local labour market segments. In addition to these fayres, there exists various opportunities across the academic year where students can engage through assemblies, visits and planned sessions.

Premises and facilities
